To Crow Wing County Campground/Resort Owners and Managers

This letter is coming to you in an attempt to foster cooperation and understanding in the assessment of travel trailers, park models and accessory structures located on leased sites.

Our appraisers will be going out to view all campgrounds by mid December this year. We are requesting that you provide us as soon as possible the names and addresses of the individuals leasing sites from you. Many of you have been so helpful and informative in the past and we thank you for your cooperation.

We are also requesting your assistance in notifying any travel trailer owners in your campground that they must by law have current registration plates conspicuously displayed on the units or they will be charged a personal property tax for that unit. We know from past experience that sometimes people have purchased current registration for their units but have not had them conspicuously displayed. We would like to alleviate this issue and the frustrations it creates for both the owners and this office starting with the 2007 assessment and any future assessments

Attached is an information sheet citing Minnesota Statutes regarding personal property assessment which you can use as reference or post for your people to see.
